AIRLINE ADM POLICY IN ALL BSP  
AIRLINE NAME: OJSC «TAJIK AIR» AIR COMPANY  
AIRLINE ALPHA + NUMERIC CODE: 7J - 502

Unless otherwise specified, OJSC «TAJIK AIR» AIR COMPANY will generally issue ADM in all BSP for the following reasons:

1. Unreported sales.
2. Implementation of sales without reporting—penalty of 200 EUR.
3. Applying incorrect commission levels
4. Issuing tickets by credit cards, not accepted as form of payment by the airline.
5. Applying incorrect taxes.
6. Applying incorrect fares.
7. Incorrectly issued ticket: Passenger Discount Type incorrectly shown in ticket – penalty of 100 EUR.
8. Double Refunds – Refunds via BSPlink and manual.
9. Reissuing tickets for interline flights without endorsement of other airlines.
10. Group name list not provided on the letterhead for team leaders when applying Group Fares.
11. Applying incorrect booking class for appropriate fare type as per fare rules.
12. Cancellation fees or Administration fees indicated in Fare Rules not deducted on refunds.
13. Cancellation fees deducted directly from the fare instead of CP Taxes
14. Commission deducted on Cancellation Fees.
15. Interline tickets issued when no interline agreement exists.
16. Ticket issued with an OPEN segment status whereas the fare basis does not permit an open segment status.
17. Ticket issued with a segment status "RQ" whereas the fare basis demands that all segments be confirmed.
18. Deducting the ADM amount from agent's commission, instead of direct payment.

OJSC «TAJIK AIR» AIR COMPANY will apply an ADM issue fee of 10 EUR or Equivalent in Local Currency, per ADM issued.

OJSC «TAJIK AIR» AIR COMPANY confirms that all ADMs can be disputed in BSP LINK. Prior to accepting or rejecting related disputes in BSP LINK, the airline or its representative will establish a correspondence with the agent to come to an agreement.
